Upcoming public meeting on the *Regulatory Oversight Report for Canadian Nuclear Power Generating Sites: 2017*

The Canadian Nuclear Safety Commission (CNSC) announces that CNSC staff will present its *Regulatory Oversight Report for Canadian Nuclear Power Generating Sites: 2017* (the Report) during the **November 2018** public meeting. This report will provide CNSC staff's assessment of the Canadian nuclear power industry's safety performance during the 2017 calendar year and details the progress of certain regulatory issues and initiatives in 2018. The Report will cover the assessment of performance of both the nuclear power plants (NPPs) and the waste management facilities (WMFs) located at the nuclear power generating sites. For the WMFs, the assessment will cover both the 2016 and the 2017 calendar years.

The specific facilities to be covered in the Report include the NPPs and WMFs at Darlington, Pickering, Gentilly-2 and Point Lepreau, as well as the NPP and the Western WMF at the Bruce site.

The public meeting will be webcast live and available on the CNSC website at nuclearsafety.gc.ca.

The purpose of the funding is to assist Indigenous peoples, members of the public and stakeholders in reviewing the Report and participating in the Commission meeting process by providing topic-specific submissions to the Commission. The deadline for submitting a completed participant funding application form to the CNSC is **June 29, 2018**.

The CNSC also announces that the draft Report will now be available for review on the CNSC website, or on request to the Secretariat, after **September 7, 2018**.
